ORDER:-

In the said Government Order a notification under clause (d) of section 2 of the Right of Children to Free and Compulsory Education Act, 2009 (Central Act 35 of 2009) 'Child belonging to disadvantaged group' has been specified so as to cover a child who is an Orphan, or affected with Human Immuno Deficiency Virus or a transgender or a child of a scavenger in addition to the definition given in the Right of Children to Free and Compulsory Education Act, 2009. Now it has been brought to the notice of the Government that child with disability may also be brought under the definition of 'child belonging to disadvantaged group' under the said Central Act 35 of 2009. Accordingly the following notification is issued.

2. The following notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION

Under clause (d) of section 2 of the Right of Children to Free and Compulsory Education Act, 2009 (Central Act 35 of 2009), the Governor of Tamil Nadu hereby makes the following amendment to the School Education Department Notification No.11 (2)/SE/444(b-1)/2011, Published at page 1 of Part-II - Section 2 of the Tamil Nadu Government Gazette, Extraordinary, dated the 12th November 2011.
