2 14 1 In the New Education Policy, among other things, a District Level Educational Institution called the District Institute of Education and Training has been conceived to improve and enrich the academic equipment of the Elementery School Teachers, Non Formel and Adult Educational Functionaries and other personnel at the lowest but important level of our educational system. This concept of District Institute of . Education and Training was accepted by this Government and orders were issued in the G.O. read above fbr setting up of . District Institutes of Education and Training in Tamil Nadu in seven districts to start with, under a centrally assisted scheme.

- . . 2. In order to equip these District Institutes of Education and Training Centres, the Director of School Education, Madras has submitted proposals detailing the staffing pattern and placement of staff in District Institutes of Education and Training. The staffing Pattern in each District Institute of Education and Training is detailed in. Annexure I to this order.
 - 3. After careful consideration, sanction is accorded for the creation of posts mentioned in Column (2) of Annexuse II to this order with the scales of pay noted against each for each District Institute of Education and Training under seven branches. The qualifications required for the posts which are prescribed by the Government of India are detailed in Annexure IV to this order. These qualifications will not be applicable to the posts proposed to be absorbed as detailed in Column (3) in Annexure II to this order. 123

4. In Annexure III to this order the posts which are to be surrendered consequent on the formation of District Institutes of Education and Training are detailed. These existing posts found surplus in view of the implementation of District Institute of Education and Training should be absorbed in the existing vacancies in other schools/ institutes etc.
